First Nation Abar'Rishoni Peoples Embassy: North, South, Central Amarucas Declares Act of 1871 United States, its instrumentalities, et al., in Violation of International Humanitarian Law, et al.,

MeTóac MonâTon IAI Territory, 2022.11.22/SAYKC IAI Int'L Herald/-- Internationally recognized First Nation Abar'Rishoni Peoples Embassy, in close monitoring of highly concerning events pertaining MISNOMER **Black African Americans** abiding IbarYath Abar'Rishoni AmaruKhan InDios (IAI) **lawfully repatriated territory**, has concluded several acts; inclusive but not limited to the most recent concerning Brooklyn Nets Kyrie Irving, Music Artist Kanye West, and Comedian Dave Chappelle, et al., to be in line with **Reverse Anti-Shemeticism in violation of international humanitarian law and treaties, et al, ALL Others;**

Reverse Anti-Shemeticism defined as the prohibition against the so-called "Negro" (Black African American, et al.) prophesied awakening after forceable denationalization, on the proven lands of their RoYaL Ancient Ones, upon European Colonization; imputing irreparable severities in violation of un-a-lien-able rights, international humanitarian law, et al., having the sole purpose of de[human]izing and silencing the Negro to prevent other Negroes' awakening to the Truth of the "Negroes" being the "TRUE" bloodline Hebrew Israelites spoken of in Scriptures;
